Policy of Waste Management

Facilities in the institution for the management or the following types of degradable and non-degradable waste:

Solid waste Management:

The practise of gathering and handling solid waste on college campuses is known as solid management. The Institution has a well-designed system in place to handle trash, particularly solid garbage. The following are the management techniques used:

- Solid waste composting process.
- Disposal by hog feeding.
- Disposal by ploughing into the fields.
- Solid waste open burning to the minimum level only in the case of stationery waste.

Every Saturday, the colleges allocated staff members collect the solid garbage, and both teaching and non-teaching staff members participate in a cleaning campaign. The designated hole that was built especially for the purpose receives the rubbish and discards it there. With the help of an MOU, the Municipality of Chirimiri regularly collects trash and helps the college keep the campus clean.
